Raven Mount says Anton Bilton, Bim Sandhu stakes rise after share issue

LONDON (AFX) - Raven Mount plc said Anton Bilton and Bim Sandhu have increased their shareholdings in the company after it issued a further 1,003,434 ordinary shares under the acquisition of Raven Property Holdings PLC.

In total, Raven Mount has now paid 33.9 mln stg for Raven Property out of a total potential payable amount of 39.9 mln.

After the issue today Anton Bilton and Bim Sandhu have a direct or indirect through trusts interest in 26,187,302 shares in the company, representing 24.29 pct and 13,098,580 shares, representing 12.15 pct, respectively.

In addition, Santon Capital PLC, which is wholly owned by Anton Bilton and Bim Sandhu, retains an interest in 7,750,000 shares, representing 7.19 pct.

The combined holding together with their interest in Santon Capital is 47,033,882 shares, or 43.64 pct.
